# C. Nature of Duties

1. Renovation of Informatics Centre (Library Building) or reconstruction/redesign of a new building after demolishing the old Informatics Block and further examination of building structure.

2. Supervise the renovation/revamping or redesigning and reconstruction work of office building.

### D. Mode of Selection

Applications received in response to advertisement will be scrutinized and shortlisted applicants will be called for personal interview/discussion. Based on the qualification, experiences & outcome of personal interview/discussion, the candidate will be selected.

## E. Terms of Engagement

- 1. The civil engineer who accepts the offer of engagement, shall sign a contract with the Academy having the confidentiality clause along with the terms & conditions of engagement.
- 2. The tenure of the civil engineer will be initially for a period of one year from the date of engagement. This can be extended one more year based on the requirement and the performance of the candidate/person. The tenure may be terminated by giving one month's notice on either side.
- 3. Civil Engineer shall be eligible for 8 days leave in a calendar year on pro-rata basis. INSA would be free to terminate the services in case of absence by more than 15 days beyond the entitled leave in a calendar year.
- 4. No TA/DA shall be admissible for joining the assignment or on its completion. However, he/she shall be allowed TA/DA for their travel in connection with the official work.
- 5. Any breach of contract executed by the civil engineer with the Academy shall be considered a sufficient ground for the termination of the engagement by the Academy.
- 6. INSA reserves the right to reject any application without assigning any reasons.

# D. Important Terms & Conditions

- 1. The Academy reserves the right to cancel the recruitment process without assigning any reason.
- 2. Candidates must ensure their eligibility before applying. The prescribed essential qualifications and experience are minimum and mere possession of the same does not entitle any candidate to be called for interview. In the event of number of applications being large, the Academy reserves the right for shortlisting criteria to restrict the number of candidates to be called for interview to a reasonable number on the basis of higher percentage of marks Or on the basis of higher educational qualifications than the minimum prescribed in this advertisement Or on the basis of higher experience Or any other method as decided by the Academy. The decision of the Academy will be final and binding on the candidates.
