#### **TERMS & CONDITIONS:**

- 1. The contract period for providing the services of pest control will be two (2) years including guarantee period for anti-termite treatments. This contract may be extended for further period of two (2) years on the basis of same rates/amount, and terms & conditions, if the services provided by the party are satisfactory and also on the discretion of competent authority of the Academy.
- 2. The firm should quote the rate of each item and total amount in figures as well as in words. The quoted rates should include all taxes, cartage, if any and any other hidden charges. No other charges other than quoted rates/amount will be paid by the Academy.
- 3. The representative(s) of the firm should visit at site before quoting the rates to make himself/ themselves well acquainted with the site conditions.
- 4. In case of any enquiry regarding tender/work the AED-II (Estate) may be contacted on any working day during the office hours.
- 5. Payment terms:
- (a) Payment against anti-termite treatment (one time) will be released 80% of value of anti-termite treatment and balance 20% will be released in two equal installments after satisfactory completion of guarantee period of each year.
- (b) Payment against general pest control, rodent control services will be released on yearly basis after satisfactory completion of each year.
- 6. The interested contracting firms may submit their sealed tender addressed to The Deputy Director-II (F&A), Indian National Science Academy, Bahadur Shah Zafar Marg, New Delhi 110 002 on or before 25<sup>th</sup> March, 2021 till 05:00 pm.
- 7. The firm should depute their representative to visit at Academy at least once in every month to check the effect of pest control and give the necessary treatment at required places. The maximum visits of the representative of the company may be up to three (3) in a month, it will depend upon the complaint noticed by the supervisory staff of the Estate Section or complaint received from various section of the Academy.
- 8. The firm/contractor will have to mandatory submitted Bid Security declaration (as per attached format) along with the tender documents.
- 9. The tenders submitted without Bid Security declaration will be rejected by the Academy.
- 10. The successful bidder has to submit security deposit @ 3% of the awarded value at the time of award of work. The security deposit will be refunded to the party after six months from the date of satisfactory completion of contract/work.

11. The tenders should be in Two Bid System <u>"Technical Bid"</u> and <u>"Price Bid"</u>. The Envelopes should contain the following documents given as under:

- 14. The firm/contractor should be registered with GST department and have valid GSTIN number. A copy of **GSTIN registration number** should be attached with tender, (GST Registration is not mandatory).
- 15. Canvassing in connection with the tender is strictly prohibited and the tenderer who resorts to canvassing his tender is likely to be rejected.
- 16. The tender document may be downloaded for CPP portal and INSA website: www.insaindia.res.in from 17<sup>th</sup> March, 2021 at 6:00 pm onwards.
- 17. The last date for submission of duly filled up tenders is **25<sup>th</sup> March**, **2021 till 05:00** pm.
- 18. The tenders shall be opened on **26<sup>th</sup> March**, **2021 at 11:00 am** at INSA in presence of parties/representatives of the firms/companies by a duly constituted committee by the competent authority of the Academy.
